BY-LAW # 2026-24

Being a By-Law to Amend By-Law 2025-26 being a By-law to govern the Operation of the Englehart and Holy Trinity Cemeteries.

Whereas By-Law 2023-02, was enacted on January 25, 2023, including the approved Schedule L, which sets out the approved Cemetery Price List;

And Whereas By-Law 2023-02 received approval by the Bereavement Authority of Ontario on February 9, 2023, excepting Schedule L, which is exempt from BAO approval;

And Whereas Schedule L – “Price List” was subsequently amended effective July 9, 2025 via By-Law 2025-26;

And Whereas it is deemed necessary to amend the fees for columbarium plaques due to increased supplier costs associated with the provision of such plaques;

Now Therefore the Council of the Corporation of the Town of Englehart Enacts as Follows:

1. **That** Schedule L – “Price List”, last amended effective July 9, 2025, by By-Law 2025-26, hereby amended to revise the fees relating to columbarium plaques, effective May 27th, 2026.
2. **That**, all other provisions remain in full force and effect, except as specifically amended herein.
3. **And That**, the Clerk of the Town of Englehart is hereby authorized to make any minor modifications or corrections of an administrative, numerical, grammatical, semantically, or descriptive nature or kind to the by-law and schedule as may be deemed necessary after the passage of this by-law, where such modifications or corrections do not alter the intent of the by-law.

Read a first, second and third and final time and passed this 27th day of May 2026.
